Five Munck Wilson Mandala Partners Honored as Best Lawyers in Dallas

Munck Wilson Mandala congratulated five partners who were selected among D Magazine's Best Lawyers in Dallas for 2019. The MWM attorneys honored were William Munck, Jenny Martinez, Jamil Alibhai, Audrey Mross, and Michael McCabe.
