Munck is also involved with an organization focused on providing meals for food-insecure students in the Dallas Independent School District, serving on the board of directors and as a member of the executive committee for Hunger Busters, a nonprofit organization that he plans to continue supporting as chairman of the board.

The first in his family to go to college, Munck earned a master's in computer science and engineering with honors, and received his J.D. with honors from Hofstra University School of Law, where he is listed among the law school's distinguished alumni.
