## Experience

- Won at trial in post-pandemic Los Angeles Superior Court on behalf of a medical office tenant defrauded by a landlord
- Successfully defended national grocery chain in seven-figure dispute filed in Los Angeles Superior Court, with landlord regarding condition of store at turnover, resulting in settlement for nominal payment to plaintiff
